#### Q3 2020 Review

#### Notable Mergers & Acquisitions and Asset Transactions

#### MERGERS & ACQUISITIONS

- France's EDF Renewables acquired a 29% stake in French start-up Ecosun Innovations, which specialises in microgrid solutions for remote locations
- WPD Invest agreed to buy French renewable energy company Atalante Energies. Augusta & Co. launched the sale of the privately-owned developer that owns an 87.7MW portfolio of operating wind farms last year, in a deal code-named Project Azalee
- Austrian electricity utility Verbund agreed to buy a 51% stake in Gas Connect Austria from oil group OMV, valuing the natural gas grid at nearly €1 billion. The companies said in a statement that Verbund will pay €271 million for the majority stake
- KKR Infrastructure closed its £4.2 billion acquisition of UK waste business Viridor from water utility owner Pennon Group. Pennon has received £3.7 billion in cash proceeds after taking into account debt and debt-like items that remain with Viridor

#### ASSET TRANSACTIONS

- Swedish wind developer Eolus Vind agreed to sell a trio of onshore wind projects to German asset manager Commerz Real for €82.5 million. Commerz Real will acquire the project rights of 24MWBoarp, 26MW Dallebo and 18MW Rosenkog. The three projects are all located in southern Sweden
- SDCL has acquired a portfolio of energy efficiency projects serving UK hotels from energy business GET Solutions. SDCL Energy Efficiency Income Trust (SEEIT) acquired 15 energy efficiency projects for £5 million
- SSE plc agreed to sell its 25.1% stake in the 367.2MW Walney offshore wind farm to Greencoat UK Wind Plc for £350 million
- Madrid-based solar projects developer X-Elio Energy SL reached an agreement on the sale of some 500MW of PV plants in Spain to China Three Gorges Europe SA. Although financial details are not disclosed, reports claim that China Three Gorges Corporation is to pay around €500 million for the assets
- Galp acquired a 50% stake in 450MW of PV projects in Ourique town, Portugal. Galp is now an equal partner in the two PV projects alongside investment firm Alpac Capital

#### Notable Fund Raisings & Project Finance Transactions

#### **FUND RAISINGS**

- Renewable infrastructure fund Greencoat UK Wind Plc said it has raised £400 million from the initial round of its 12 month share issuance programme. Greencoat will allocate the net proceeds mainly to repay debt
- Italy-based Falck Renewables SpA announced it will raise €200 million in what it says is the first green equity-linked bond offering in Italy. The senior unsecured zero-interest bonds, due in 2025, will be sold at a price of 101.25% of their nominal value with an annual gross yield-to-maturity of -0.25%
- EDF launched a green bond offering of up to €2.4 billion aimed at financing projects that will help it reach its 2030 renewables goal
- Equitix held a final close of its first infrastructure fund focused on continental Europe. Equitix European Infrastructure Fund I secured €558 million of commitments

#### PROJECT FINANCE TRANSACTIONS

- Macquarie Infrastructure Debt Investment Solutions (MIDIS) has committed £120 million to a syndication of debt put in place by KKR to acquire UK waste management business Viridor
- Turkish power generation company Enerjisa Uretim Santralleri said it has inked a sustainability linked loan agreement worth €650 million with seven banks. The seven banks that are providing the financing are Akbank, Garanti BBVA, Turkiye Is Bankasi, HSBC, ING, TEB and Isbank
- Valorem has completed an estimated €300 million refinancing of a portfolio of onshore wind and solar assets it owns in France. Credit Agricole, Bpifrance and Societe Generale have committed the debt package, which comprises 11 wind farms and two PV plants with an aggregate capacity of 165MW
- Banca IMI and Mediobanca completed the syndication of a €825 million debt package backing F2i and Asterion's takeover of Italian utility Sorgenia. The two underwriters syndicated the debt to a pool of banks including Italian lenders Banco BPM, BPER Banca, MPS and UBI Banca, plus foreign banks ING, Kommunalkredit and Natixis
